## EXAMINATIONS

Just to refresh you that the Institute holds two biannual examinations in January & July each year. On revision in syllabus w.e.f. July 2006 examination, groups have been reduced from 8 to 6 and subjects from 16 to 13 subjects.

## REFERRAL POLICY

The Institute has adopted the following Referral Policy in CIS examination effective from July 2009:

- (i) Assessed passing marks for all groups would be 40 as per existing policy.
- (ii) Students who have passed one paper in a group without grace marks and obtained marks ranging from 21 – 29 in another paper, the said paper will be treated as referred for next two attempts provided that he gets assessed required marks i.e. 40 marks without grace marks. In case of not passing the paper in subsequent two attempts he would be required to reappear in whole group.
- (iii) A student securing assessed passing marks i.e. 40 marks in each two papers of a group containing three papers, remaining paper will be treated as referred for next 2 attempts provided he gets marks in the range of 21 – 29 in the said paper.
- (iv) The grace marks upto 10 would now be allowed in any one paper to the student subject to the condition that after allowing grace marks he would pass the whole group.
- (v) Permanent exemption will now be granted on achievement of 60% assessed marks in the paper instead of 70% marks, without having grace marks.
- (vi) Any special case may be considered by the National Council.

## RESULTS

Examinations of the Institute were held at Karachi, Lahore and Islamabad in January and July, 2011 as per the examination schedule.
